Saving Georgia Dogs, Inc. agrees to allow _____ to act as a foster home under animal shelter the license issued by The Georgia Department of Agriculture. All animals remain the property of the animal shelter and as such, must be returned to the animal shelter upon request. No animal will be removed from or returned to the animal shelter without authorization. Foster home agrees to initial and periodic inspections by the animal shelter personnel and the Department of Agriculture. Foster home premise and all enclosures must be kept in good state of repairs at all times. Each building housing animals will have a fully functioning fire extinguisher and/or smoke or fire alarm. All enclosures will be cleaned daily and as often as needed during the day to prevent odors. Housing areas should be well ventilated to provide fresh air and to minimize odors and moisture. All animals must have fresh water daily and checked during the day. Medical treatment must be provided when needed. Foster animals being housed outside must have appropriate shelter and adequate enclosures. No foster animal will be held by means of tethering.
